## MESSAGE FROM THE PRESIDENT

## Reflections from President Carlo Signorelli delivered on 03 May at the Opening Ceremony of the 17<sup>th</sup> World Congress on Public Health, Rome, Italy.

Dear Authorities, Dear Colleagues and Friends, Ladies and Gentlemen,

We have been working on this World Congress on Public Health since 2016. Let me therefore share with you the satisfaction and also the emotion for having organized an event with 3,000 delegates in person and thank all who have collaborated over the past seven years to make it possible, through various organisational phases, when manoeuvring to an online event in 2020 due to pandemic restrictions, to arriving at today's grand opening ceremony with so many of you here.

The organisation of this congress has allowed me to participate in various meetings and events on all continents, from Havana to Taipei, from Kampala to Melbourne, from Sofia to Washington DC. In all of these happenings, before and even more after the pandemic, the importance of public health and the public health workforce has emerged; the irreplaceable role of public health to guard politicians and health policymakers to make the best possible decisions, and the strategic role of public health professionals who must be – now more than ever – trained in the best way.

That is why today I am delighted and honoured to be on this stand as President of ASPHER, the Association of Schools of Public Health in the European Region, whose fundamental mission is threefold. And thirdly, in a field that is cross-sectoral, multidisplinary, and interprofessional in spirit, to build coalitions with other programmes and organisations.

Working with others is a mainstay for ASPHER, featuring prominently in the Association's active collaboration in this event — first and foremost with the official launch of the Global Network for Academic Public Health (GNAPH), bringing associations of schools of public health together from around the world, and whose constitution is expected to be signed in a session later this afternoon. We look forward to the continued partnership with the World Federation of Public Health Associations, for GNAPH and its regional schools' networks to act as partners in future World Congresses. Please consider following the ASPHER and GNAPH sessions scheduled in the Congress programme, as well as the plenary session 7 on skills and capacity for health improvement to which both are contributing.

ASPHER is also a partner to and a member of the European Public Health Alliance (EPHA). Recognizing the adversities we face in a World in Turmoil, the Association together with EPHA will be calling for concerted action glocally, reflecting both global and local considerations, on Public Health Advocacy. We will do so with a manifesto for systematic cooperation and collaboration of all who support Public Health's core values. I urge you to join the ASPHER-EPHA session today to answer the call and sign the manifesto for People and Planet, for Evidence, for Trust, for Partnership, and for Investment. We must act now!

## JOIN THE GLOBAL NETWORK FOR ACADEMIC PUBLIC HEALTH SESSIONS



#### 3 May, 18:30-19:30 CET, Sala Tarragona Global collaboration in academic public health

This session will discuss the importance of global collaboration in academic public health and introduce the Global Network for Academic Public Health, an alliance of seven regional associations that represent schools and programs of public health worldwide. The purpose of the Global Network is to enhance academic public health worldwide through mutual learning and collaborations between academic public health institutions globally in order to improve and protect the health of people and the planet.

#### 4 May, 9:00-10:30 CET, Sala Tarragona Ethics and academic public health

This session will discuss public health ethics from the perspective of academic public health. Public health ethics is a core cross cutting competency for good public health practice, but ethics has not been widely taught in schools of public health or other training spaces. The session will provide an opportunity to reflect, consult, share and consider options for collaboration to further advance the discourse, scholarship and practice of public health ethics to promote and protect the public's health.

#### 4 May, 16:30-18:00 CET, Sala Massalia Innovations in academic public health – where do we go next?

This session will discuss innovations in, and the future of, academic public health. The first part of the session will showcase three examples of innovations in training the next generation of public health professionals. The second part of the session will be a workshop to teach creativity and innovation in public health curricula via design thinking.

#### 5 May, 10:00-11:00 CET, Sala Tarragona Capacity building and professionalization of the public health workforce – Part 1

This session will focus on building the capacity of the public health workforce globally. It will present the WHO roadmap on National workforce capacity to implement the essential public health functions including a focus on emergency preparedness and response, as well as how partners can be involved. Perspectives on building capacity will be shared from the perspectives of national public health institutes and academic public health.

#### 5 May, 11:30-13:00 CET, Sala Tarragona Capacity building and professionalization of the public health workforce – Part 2

This session follows on Part 1 and showcases initiatives that align with the WHO roadmap on National workforce capacity to implement the essential public health functions including a focus on emergency preparedness and response. The session will highlight building public health workforce capacity and professionalization is being addressed in the context of different countries and regions.

### Andrija Štampar Medal

The Andrija Štampar Medal recognizes outstanding lifetime achievements in the public health teaching, research or practices of an esteemed individual within the public health community. Nominees do not need to be a current or past faculty member of an ASPHER member school.

Nominations should include a description of the nominee's outstanding contributions in: demonstrating leadership in advancing health equity, member-focus, diversity, integrity, corporate-citizenship, Europe-centred global outlook and/or meaningful work (ASPHER core values) in the fields of academic public health research, teaching and practice; demonstrating national and/or international visibility of the accomplishments within and outside scientific community; lasting, equitable and sustainable contributions in advancing public health teaching, community-building, implementation and research.

### **ASPHER Research Excellence Award**

This award recognizes outstanding achievements in public health research. It is given annually to an individual – on behalf of their research team – primarily affiliated with an ASPHER member school.

Nominations should include a description of the nominee's outstanding contributions in: demonstrating leadership in advancing health equity, member-focus, diversity, integrity, corporate-citizenship, Europe-centred global outlook and/or meaningful work (ASPHER core values) in the field of academic public health research; outstanding exemplary and documented

scholarly accomplishments in the form of a notable record of success; innovative research advancing the research mission of the field of public health and improving the health of communities they serve; demonstrating national and/or international visibility of the accomplishments.

### ASPHER Teaching & Practice Excellence Award

This award recognizes outstanding achievements in public health teaching and practice of a Programme or School of Public Health within the ASPHER community. It is given to an ASPHER member school or ASPHER-member programme of public health.

Nominations should include a description of the nominated SPH outstanding contributions in: demonstrating leadership in advancing health equity, member-focus, diversity, integrity, corporate-citizenship, Europe-centred global outlook and/or meaningful work (ASPHER core values) in the field of academic public health teaching or practice; documented engagement beyond the immediate School of Public Health (SPH), e.g. through collaborative work with several SPHs (within the ASPHER community); demonstrating national and/or international visibility of the institution; innovative, creative efforts in education or practice to overcome obstacles (e.g. political, societal, teaching-related) in challenging settings.

### **ASPHR Early Career Excellence Award**

This award recognizes outstanding achievements in the field of teaching, research, or practice of early career individuals. It is given annually to a maximum of five individuals that are primarily affiliated with an ASPHER member school. Early career positions considered for this award include up to assistant/associate professors.

Nominations should include a description of the nominee's outstanding contributions in: demonstrating leadership in advancing health equity, member-focus, diversity, integrity, corporate-citizenship, Europe-centred global outlook and/or meaningful work (ASPHER core values) in the field of academic public health teaching, research or practice; outstanding exemplary and documented scholarly accomplishments in form of a notable record of success; innovative research, teaching or practice advancing the mission of the field of public health and improving the health of communities they serve.

## Conflict in Sudan

Dr. Haitham Bashier, Executive Director of ASPHER Associate Member, the International Academy of Public Health IAPH and Joanna Samhouri, Master's student of Global Public and Environmental Health at New York University wrote to ASPHER regarding the conflict in Sudan.



Here is an excerpt of what they sent:

On Saturday April 16, during the holy month of Ramadan, the people in Sudan woke up to open gunfire between the Sudanese Armed Forces (SAF) and the Rapid Support Forces (RSF). The crossfire initially began in West Darfur and later spread to Khartoum and neighboring areas. People in Sudan have suddenly, without prior notice, lost their access to essentials of life. The political upheaval has robbed them from their rights to food, water, shelter, and access to healthcare services. Some have left their homes and fled in search of safety and security and others have witnessed the annihilation of their houses as a result of the shooting. Destruction of schools and universities have led students to visualize the end of a path yet to begin. There are still more unfortunate souls who, with their naked eyes, saw the killing of their families, loved ones, and friends. To add misery to their pain, the martyrs are scattered everywhere around on the streets, tainted with blood, waiting to be buried. More fortunate people are confined in their homes, restricted of movement, hugging their family members tight in fear of losing any of them.

People are suffering from a shortage in water supply, unreliable electricity, and interrupted communication services. Even those who have the means of purchasing food and water are in shackles chained with the fear of getting shot with any movement. It is of utmost priority and urgency to highlight the challenges the healthcare system is exposed to as a result of the current life-threatening situation Sudan is facing.

## Education and training for a strengthened public health workforce in South Africa and UK

On 13 April, the UK Faculty of Public Health and the College of Public Health Medicine South Africa held a knowledge exchange webinar on globally relevant lessons learnt in the implementation of competency-based education and training for a strengthened public health workforce in South Africa and UK.

This session engaged participants in the roadmap developed by WHO and partner organisations to strengthen the global public health workforce. The session shared globally relevant lessons,

learnt from the UK and South Africa, in the implementation of competency-based education and training as an approach to developing the skills and abilities of the public health workforce.

## Revolutionizing the Public Health Workforce - A Policy Brief in Retrospect of the World Congress on Public Health, Rome 2020

The COVID-19 pandemic dramatically illustrates the consequences of inadequate prioritization of the Public Health Workforce. This Policy Brief introduces a Call for Action following the plenary session entitled "Revolutionising the PH Workforce as Agents of Change" as part of the 2020 World Congress on Public Health.

### **Policy Options and Recommendations:**

In order to revolutionize the PH Workforce, five long-term key approaches are proposed:

- 1. Transforming public health competencies through transdisciplinary education and inter-professional training;

## DisQo Anti-Discrimination & Health Equity Joint Statement

## Organisations across sectors call for stronger action against racism and discrimination to achieve health equity

ASPHER has signed the DisQo Joint Statement on anti-discrimination & health equity which was presented formally to DG SANTE on the 19th of April at the <u>EU Health Policy Platform Annual Meeting</u>.

Despite the increasing evidence showing that structural, institutional, and interpersonal racism and discrimination impact both physical and mental health inequities in multiple ways, the issue has gained too little attention in the public health domain thus far.

## The statement has identified five key priorities for addressing the issue in a constructive, respectful, and participatory way:

- 1. Recognise racism and discrimination as fundamental determinants of health, equity and well-being
- 2. Strengthen social participation of racialised and discriminated communities, and foster diversity, representation and anti-discrimination
- 3. Increase clarity and consistency of key definitions related to racism, discrimination and health equity
- 4. Collect more (health) equality data, disaggregated by indicators on multiple grounds of discrimination, and harmonise EU data collection
- 5. Strengthen existing EU anti-discrimination legislation by breaking down silos and boosting policy mainstreaming, transparency, reparative justice and social participation

# WHO technical consultation for building a global curriculum for infodemic management

To develop infodemic management capacities for the future, WHO convened a technical consultation on building a global curriculum for infodemic management on 21-23 March in Belgrade, Serbia. Hosted by former ASPHER President Vesna Bjegovic Mikanovic and the Centre – School of Public Health, Faculty of Medicine, University of Belgrade, the consultation brought together 47 representatives of academia, public health and professional associations, and health authorities from six WHO regions.



With the aim to (i) define the capacities for mainstreaming infodemic management in learning and training programmes, and (ii) mapping integration approaches in existing education and learning programmes, the consultation offered a platform for a productive discussion. The competency framework defines the key functions of an Infodemic manager throughout the epidemic response cycle and how adaptive they become as the epidemic evolves.

A meeting report and a plan for mainstreaming infodemic management into learning and teaching programmes is forthcoming. ASPHER will keep an eye on the outcomes of the work ensuring synergy with the Association's relevant activities.

# Honorary Doctorate awarded to Ilona Kickbush by the University of Valencia

The investiture of the professor and global health expert Ilona Kickbusch as Doctor "Honoris Causa" by the University of Valencia took place last Friday 24th March in the auditorium of the emblematic building of La Nau.

The investiture was attended by a large representation of the University's Board of Directors, most of the deans of the institution, as well as members and representatives of the different groups of the university community.



The Rector of the University of Valencia, Maria Vicenta Mestre, presided over the solemn ceremony, and the professor of the Department of Preventive Medicine and Public Health, Jose M. Martin-Moreno, was in charge of reading the <u>laudatio</u>. The investiture was attended by a large representation of the University's Board of Directors, most of the deans of the institution, as well as members and representatives of the different groups of the university community.

The awarding of this recognition as Doctor "Honoris Causa" to Ilona Selma Kickbusch by the UV has been promoted by the University itself as a result of her undoubted leadership in the field of health promotion and for her outstanding role in the world of political science and sociology, all from a feminist perspective.



In <u>Dr Ilona Selma Kickbusch's lectio</u>, she took the opportunity to talk about the importance of the digital transformation of health and the convergence between digital health and public health, highlighting the role this has played during the COVID-19 pandemic. In addition, she reflected on whether we should think of digital transformation as a multidimensional determinant of health, whether the understanding of solidarity in health should be broadened to include data solidarity, and whether we should develop a concept of digital health citizenship.

For her part, the <u>Rector of the University of Valencia stressed in her speech</u> that this distinction as Doctor "Honoris Causa" is received by "a committed woman, as well as a scientist who has not only researched but, as published in 2017 by the prestigious journal "The Lancet", has a 'distinguished career in the World Health Organization, the Government and academia, a career that has contributed to shaping global health". During his speech, Mestre also spoke of the presence and importance of health sciences at UV.
