# 11th EUROPEAN PUBLIC HEALTH CONFERENCE Report from Ljubljana, Slovenia

#### Coalition of Partners and Public Health Workforce Professionalisation

The 3rd meeting of the <u>WHO Coalition of Partners</u> was held back to back, prior to the conference. The meeting included representatives from countries throughout the European Region and was used among other things to disseminate information on key documents put together as a joint action between WHO Europe, ASPHER and APHEA working toward the professionalisation of the public health workforce.



ASPHER President, Professor Katarzyna Czabanowska, has now been added as a member of the Core Team of the WHO Coalition of Partners.

#### Young Researchers' Forum

The 11th edition of the Young Researchers' Forum was held in Ljubljana, on 28 November 2018, prior to the European Public Health Conference, supported by the Swiss School of Public Health+ and the European Public Health Association (EUPHA).

About thirty young researchers, representing various European countries were at the forum to present their research and also engage with fellow young researchers. The forum was chaired by Professor Vesna Bjegovic-Mikanovic, ASPHER Past President from the University of Belgrade. ASPHER President – Professor Katarzyna Czabanowska, from Maastricht University, gave the opening remarks. The judges group, led by Professor Bjegovic-Mikanovic, included Dame Professor Anne Johnson, 2018 Andrija Stampar Medallist, Professor Karolina Lyubomirova, from the ASPHER Executive Board, and Professor Anders Foldspang, from the ASPHER Honours Committee.

We had brilliant presentations from our young researchers, they shared their research methodologies, practices, experiences, learnt from one another and were also advised by the judges. Dame Professor Anne Johnson gave the closing remarks.

The winners of the oral presentation were: Joseph Muwonge Junior, from the University of Gothenburg, Sweden who took the first prize for his oral presentation on "Prevalence and clinicalrelated correlates of suicidal behaviour in Rwandan young adults: Data from a population based, cross-sectional study"; Ana Henriques, from the University of Porto, Portugal came in second for oral presentations with "Social inequalities and quality of life among older people: the mediating role of social support"; and Julia Nadine Doetsch, from the University of Porto, Portugal took the poster presentation prize with her work on "Neoliberal Policy Impact on Health Care Provision for Parents of Very Preterm Born Infants in Portugal: A Quality Analysis on Perceived Care."



We congratulate all the presenters and winners. We look forward to the next Young Researchers' Forum in Marseille, France.

#### Mig-H Training Dissemination Workshop

A Dissemination workshop was held for the EU-funded service "Development of specific training modules for health professionals, law enforcement officers and trainers, on migrants' and refugees' health, addressing communicable diseases and mental health problems" (<u>MIG-H</u> <u>Training</u>). The project was implemented by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH, the International Organization for Migration (IOM), the London School of Hygiene and Tropical Medicine (LSHTM) and ASPHER.

MIG-H Training developed and piloted training modules for health professionals and law enforcement officers in touch with migrants and refugees, specifically targeted at closing knowledge gaps in the fields of communicable diseases and mental health issues. Pilot trainings were implemented in Bulgaria, Croatia, France, Greece, Italy, Malta, Norway, Serbia, Slovenia and Spain over the summer 2018.

IOM's Dominik Zenner was quoted as saying "today we presented new training materials on migration health, adaptable to local contexts; they are useless if they collect dust on a shelf. The real dissemination work to benefit migrants starts now."

#### Andrija Štampar Medalist, Professor Dame Anne Johnson

<u>Professor Dame Anne Johnson</u>, Professor of Epidemiology and Director of the Centre of Infectious Disease Epidemiology at University College London was awarded the prestigious 2018 Andrija Štampar Medal for excellence in the field of public Health. She gave her Keynote speech on Core Capacities to Address the Threat of Communicable Diseases.

In the Laudatio for Dame Professor Anne Johnson, Kasia Czabanowska, ASPHER President, emphasised numerous scientific achievements of Professor Johnson including seminal discoveries in behavioural and biological transmission dynamics and prevention of HIV, sexually transmitted and other infections, including influenza; internationally leading work across disciplines, countries, geographies and histories; and ability to translate her world-leading research into public health benefit, through engagement with policymakers, practitioners and independent advice to funders and government. Czabanowska stressed the leadership of Dame Professor Anne Johnson, which is reflected in her engagement in developing other professionals through mentorship, supporting more junior colleagues to navigate through academic careers, cultivating male and female mentors helping them to understand the hierarchy, and addressing barriers.

"Science is a tough road but exciting, you need to have your own idea all the way but there are many paths to success" as Dame Professor Johnson states "you just need to choose your own".

Professor Dame Johnson was on hand to speak to the next generation of public health professionals at the Young Researchers' Forum.

She also participated in the EUPHA, ASPHER, WFPHA Roundtable on Women Leaders in Public Health along with



ASPHER President, Professor Katarzyna Czabanowska, University Maastricht; Professor Anna Odone, University Vita-Salute San Raffaele, Milan; and Professor Bettina Borisch, World Federation of Public Health Associations.

#### Salzburg Seminar: Public Health Law

Scott Burris and Katarzyna Czabanowska, ASPHER President, co-directed the Salzburg <u>Seminar</u> on <u>Public Health Law</u> from 18-24 November 2018. The seminar was a collaborative effort between the <u>Open Medical Institute</u> (OMI), Maastricht University and ASPHER. Material from the seminar may contribute to ASPHER's plans to develop a strong continuing professional development (CPD) programme for Europe's public health workforce via the Association's Public Health Training Academy project.

Speakers included Suzanne Babich, DrPH, MS Associate Dean of Global Health Professor of Health Policy and Management, Director - Doctoral Program in Global Health Leadership (DrPH) Indiana University Richard M. Fairbanks School of Public Health, IN USA; Scott Burris, JD, AB Professor of Law and Public Health, Director - Center for Public Health Law Research Temple University, PA USA; Katarzyna Czabanowska, Dr. habil. Associate Professor Maastricht University, The Netherlands; Tobias D. Gantner, MD, PhD, MBA, LLM HealthCare Futurists GmbH Founder & CEO, Director of the European Center for Patient Centric Innovation and Medical Entrepreneurship, Strategic Advisor European Connected Health Alliance Cologne Germany; Farhang Tahzib, MD Senior Public Health Physician and Leader, Founding Chair of the UK Faculty of Public Health Ethics Committee, Fellow and Member of the Faculty Board, United Kingdom; David Townend, Prof., Dr., FRSA Department of Health, Ethics and Society, Maastricht University, The Netherlands; and Genc Burazeri, MD, PhD Professor of Epidemiology and Research Methods, Department of Public Health, Faculty of Medicine University of Medicine, Tirana, Albania.



The programme included keynotes on "5 Essential Public Health Law Services" and "The Future of Public Health Law." Topics included analysis of Global Public Health Policies; the Role of Stakeholders; Enforcing and Defending Legal Solutions; and the Role of Leadership in Introducing and Defending Legal Solutions; Public Health Ethics; and EU Health Law. There were Group Work Sessions held throughout the week and a Workshop on How to Develop a Case.

#### Salzburg Seminar: Human Rights and Patient Care

Judith W. Overall and Robert Otok, ASPHER Director, co-directed an Open Medical Institute (OMI) and ASPHER seminar on <u>Human Rights in Patient Care (HRPC</u>) from 25 Nov-1 Dec 2018. The seminar was linked to the ASPHER HRPC programme, which ASPHER has proudly been a continuing part of. We look forward to taking part in further developments in HRPC - look for updates to be made available via <u>health-rights.org</u>.

Speakers included Judith W. Overall JD, MS, MEd, consultant; Tamar Ezer, BA, JD, LLM Associate Director, Practitioner-in-Residence, Human Rights Clinic and Lecturer in Law University of Miami School of Law, USA; David Larios, Professor National School of Public Health, Madrid, Spain; John Kennedy, Purple States LLC Black Mountain, NC USA; Maya Peled-Raz, MPH, LLB, PhD Lecturer University of Haifa School of Public Health, Israel; and Dainius Puras, MD UN Special Rapporteur, Vilnius, Lithuania. The seminar included an overview of HRPC; panel discussion, presentations and group work on Production of HRPC Practitioner Guides; presentation of video and digital resources; examples of HRPC with training of Lawyers, Health Care Providers, Public Health Managers, Patients and Patient Representative; and discussion of papers published in the <u>HRPC collection</u> in ASPHER's journal, *Public Health Reviews*.



#### Undergraduate Education: Maastricht University Visit to AAC

An agreement between Ashkelon Academic College (AAC), Israel and Maastricht University, Netherlands to exchange visits by senior faculty members was funded by the Israeli Council of Higher Education (MALAG). The first step was a visit by senior Maastricht faculty members from the Faculty of Health Sciences to AAC in November 2018. The delegation included Professor Jascha de Nooijer, Professor Kasia Czabanowska, Mr Robert Otok and Ms Lore Leighton for The Association of Schools of Public Health of the European Region (ASPHER). Israeli participants included Professor Ted Tulchinsky, Dr Zohar Mor, Dr Osnat Bashkin, Dr Yael Ram, Professor Yehuda Neumark from the Hebrew University, Professor Orna Baron-Epel from Haifa University, Professor Nadav Davidovich and Dr Keren Dopelt from Ben Gurion University, Ms Dina Dallero and Ms Deena Tsameret from Erasmus Jerusalem.

The visit included meetings with faculty of AAC School of Health Professions. Selected students from <u>AAC's Bachelor in Public Health programme</u> presented their ongoing and planned research projects. The group planned to visit Bedouin villages in the Negev and Barzilai Hospital, however, due to a security emergency of rockets from Gaza the plan had to be cancelled. Instead, the group

visited south Tel Aviv where many migrants live. They toured a maternal and child health clinic and a primary health care clinic, which caters to undocumented migrants.



Opportunities for further exchange between EU and Israeli SPHs were discussed and a delegation from AAC is expected to come to Maastricht in September 2019.

#### Joint Action on Health Information (InfAct)

ASPHER is joining EUPHA as an external evaluator for the <u>InfAct Joint Action on Health</u> <u>Information</u>. InfAct is a 36 months project funded by the European Commission. It builds on the <u>BRIDGE Health project</u> and other initiatives in health information. The project was launched in March 2018. It includes 40 partners in 28 EU and associated countries.

Through country collaboration, InfAct streamlines health information activities across Europe. It builds towards a sustainable and solid infrastructure on EU health information and strengthens its core elements based on capacity building, health information tools and political support.

The goal of InfAct is to strengthen national and EU health information systems by:

1. Establishing a sustainable research infrastructure to support population health and health system performance assessment,

2. Strengthening European health information and knowledge bases, as well as health information research capacities to reduce health information inequalities,

3. Supporting health information interoperability and innovative health information tools and data sources.

Amongst other plans, InfAct aims to develop a flagship training programme to improve Member State capacities in population health and health system performance analysis and monitoring. # **UPCOMING EVENTS**

#### 2019 ASPPH Annual Meeting

The Association of Schools and Programs of Public Health (ASSPH) will hold their <u>Annual Meeting</u> from 20-22 March in Arlington, Virginia, USA. The Annual Meeting is the premier professional development and networking event for academic public health professionals and partners and features programming relevant to academic public health, global health, current public health concerns, and the future of these fields, including an Undergraduate Public Health and Global Health Education Summit on 20 March. During the meeting, ASPHER and ASPPH will have a number of meetings to synergize our efforts within the public health workforce professionalisation agenda, including ASPPH's This is Public Health (TIPH) Campaign, and ASPHER's European professionalisation work with WHO and the Coalition of Partners.

Specific ASPHER highlights, include:

The global engagement and partnership advisory committee meeting on Thursday morning. It will be a core platform for the joint agenda and strategy planning with key members from ASPPH and others.

ASPHER Director, Robert will speak at the Migration Concurrent Session, the EU and broader European Region migration context and efforts within the European public health community to address migrant health. He will present ASPHER's work with the International Organization for Migration (IOM) and other partners on MIG-H and TRAIN4M&H as well as other coordinated efforts with the EC and WHO.

ASPHER Executive Board Member, Carlo Signorelli will meet with international partners over dinner on Thursday evening to discuss Rome 2020, 16th World Congress on Public Health related planning. He will be encouraging schools of public health to take part in a strong and concerted action, taking stock of all the exciting developments and collaborations currently taking place.

The intention will be to place the public health training and schools context high on the agenda of this key event next year.

#### European NPHI Directors' Meeting

Since 2006, IANPHI has supported a <u>European NPHI Directors' Meeting</u>. These meetings, hosted by member national public health institutes provide opportunities for directors to gather and exchange information, discuss health topics of interest to the region, and network to build and strengthen partnerships between NPHIs.

The 2019 Meeting will be hosted by the National Agency for Public Health of the Republic of Moldova from 8-9 April 2019 in Chisinau. For more information visit the meeting <u>website</u>.

#### Joint IANPHI-WHO Technical Meeting: Establishing national public health institutes through mergers?

The International Association of National Public Health Institutes (IANPHI) and the World Health Organization (WHO), Regional Office for Europe will hold a joint technical meeting addressing: *Establishing national public health institutes through mergers – where are we now?* The meeting will be held from 9-10 April, in Chisinau, Republic of Moldova. This event is to be held within the context of the Coalition of Partners initiative to strengthen public health services and capacities in the European Region.

Last year WHO-IANPHI successfully held a <u>technical seminar in Warsaw</u>, <u>Poland in April 2018</u>, with participation from Kazakhstan, Kyrgyzstan, Republic of Moldova, and Ukraine. Belgium, France, Norway and Sweden shared their experiences of their recent mergers to establish their national institutes.

This year, WHO-IANPHI, are convening a follow-up technical seminar where Kazakhstan, Kyrgyzstan, Republic of Moldova and Ukraine can reflect together on the last year of strengthening their national institutes and share their learning with other countries, including Croatia and Scotland. Experts from countries that have gone through the process, such as Belgium, France, Norway and UK will again be on hand to lend support. The focus of this technical meeting will be around strengthening and developing the public health workforce. It will also follow up on the current status of establishing the National Public Health Institutes (NPHI), and provide cased-based strategies in strengthening the capacity of merged NPHIs. Kasia Czabanowska will be participating in the meeting in her capacity as WHO temporary adviser.

### Train 4M&H dissemination workshop

Following the MIG-H event in Ljubljana, ASPHER is continuing its participation in <u>migration</u> <u>health training actions</u> with TRAIN4M&H. A dissemination workshop for the project will be held in Brussels on 25 June. Look for further details and final dates to be announced at <u>www.aspher.org</u>. As part of its role in the action, ASPHER will host a web platform with training material developed as a result of both projects. It will be set up as a dynamic online environment and reference point for up-to-date training resources on migration and health. The online

platform will serve to disseminate MIG-H/TRAIN4M&H among all ASPHER members, but will also allow you and other contributors to upload and share your relevant content based on international, country and local experience and actions. We expect that the platform will contribute to the development of the Public Health Training Academy as a Europe-wide continuing professional development (CPD) scheme for the public health workforce. ASPHER plans to utilise it as a model for training content related to other projects, such as Human Rights in Patient Care (HRPC) and the InfAct Joint Action.

Executive Course on Health Risk Strategies and Communication (RISC) in the European Union

From 16-17 May, Maastricht University will be holding an Executive Course on Health Risk Strategies and Communication (RISC) in the European Union at its Brussels Campus.

This course has been developed for those that work within a think-tank, a European institution, an NGO or in the private sector; and have to assess and then communicate about risks within their own institution or wish to acquire the skills to do so in the future. Participants will examine questions related to risk governance together with other professionals working on risks in the health sector in the heart of the European Union, at Maastricht University Campus Brussels. Scholars from different disciplines, reaching from psychology and neuro-sciences to business and economics channel their expertise together with highly experienced professionals. #### Two-day Postgraduate Course on Health Technology Assessment

Maastricht University is organizing a two-day post-academic course Health Technology Assessment (HTA) on the 27 and 28 June in Maastricht. This course focuses on economic evaluation studies, that provide insight into the efficiency and sustainability of healthcare.

Due to a number of developments, there is a growing need for knowledge about efficiency in healthcare, such as rising healthcare expenditure, expensive medicines, increasingly complex healthcare demand, and the threat of scarcity on the healthcare labor market. In addition, new interventions are often more effective, but they are associated with higher costs than existing care. The question that arises is how much society is willing to pay to achieve extra health benefits. But also whether we provide the right care by the right person at the right place. The use of HTA / economic evaluation studies provides insight into this and can make an essential contribution to more efficient healthcare and the (further) development and prioritization of (new) treatments within healthcare. Research into this type of information is increasingly central to the various grant providers, f.i. European Calls.

This HTA course provides insight into the basic principles of economic evaluation studies and will focus in particular on aspects that are important in research into efficiency, so that after the course participants are able to - in addition to research into the effectiveness of the intervention - also have an economic set up an evaluation study. This intensive course will be given in English and is suitable for every scientist without any prior knowledge in this field. Within the course, lectures are alternated with interactive teaching methods. During the course there is also the opportunity to look at the possibilities for economic evaluation studies within the research of the participants.
