Climate crisis, heat stress, infectious disease threats: Health impacts and solutions in Europe

Wednesday 9 November 2022, 14.00 – 15.00 CET, Brussels time

The **climate crisis is increasingly affecting our health and wellbeing**. In August this year, around the same time when millions of Europeans suffered from **record-breaking high temperatures**, new research published in the science journal *Nature* suggested that climate change can aggravate over half of known **human pathogenic diseases**¹.

Developed under the <u>European Climate and Health Observatory</u> initiative, the new European Environment Agency report 'Climate change as a threat to health and well-being in Europe: focus on heat and infectious diseases' puts these two threats in sharp focus, and it outlines solutions in policy and practice.

Coinciding with the launch of the report, **this online webinar** will provide you with the report's **key findings**, and with **insights into related EU policy responses and developments**. You will also have the opportunity to **discuss** ways of minimising climate-related health threats through more resilient health systems, and adaptive actions in health sector and other policy areas.
