Please be advised that online registration ahead of the Conference is a mandatory requirement for all participants, failing which you may be denied access to the Conference premises on arrival. Registration is already open and participants are kindly encouraged to register as soon as possible.

On-site:

Upon arrival in Tallinn, registration and **advance check-in** for the Conference will be open at the main lobby of the Nordic Hotel Forum and Tallink Spa & Conference Hotel on the day prior to the start of the event, **11 December 2023** between **18:00** and **20:00**.

On the first day of the Conference (12 December 2023) registration will be open at the venue (Kultuurikatel) from **08:00**.

Meals

The following meals will be provided on both days:

- morning coffee break
- lunch
- afternoon coffee break

Official reception

We are pleased to invite you to an **official reception** in the evening of 12 December 2023. More details will be provided closer to the event.

Arrival at the airport

Upon arrival at Tallinn International Airport, participants are requested to go to the **Conference information desk**, which will be located outside the arrival hall. Staff at the information desk will assist participants and help to arrange transfers to your hotels.

Organized transport will be provided between the airport and recommended hotels (Tallink Spa & Conference Hotel, Tallink Express Hotel, Nordic Hotel Forum – please see Accommodation section below). To facilitate the organization of transfers, participants are requested to indicate their flight and hotel details in advance when registering online.

Transport

The venue is located a short walk from the recommended hotels. (see Annex 1: Suggested walking routes from recommended hotels to conference venue)

Transport will be provided in the following instances:

- from the airport to the recommended hotels;
- on 12 December, from the recommended hotels to the dinner venue and back to the recommended hotels;
- on 13 December, after close of the event, from the conference venue to the airport.

Participants who indicate in the registration form that they have mobility-related difficulties will be contacted separately to agree on their transportation needs.

Participants who prefer to stay at hotels other than those recommended are responsible for their own transport to and from their hotel and the conference and dinner venues (<u>Forus taxis</u> and <u>Bolt ride</u> are available in Tallinn and cost no more than 15 euros).

Visa

Participants are kindly requested to check whether they require a visa to enter Estonia and to apply for it in a timely manner.

Accommodation

Participants are advised to book a room in one of the recommended hotels with negotiated rates before 1 November 2023.

Please note the following:

- The special room rates only apply for 10–14 December 2023.
- Room availability and applicable rates cannot be guaranteed after 1 November 2023.
- Participants should pay their hotel directly unless a special arrangement has been confirmed by the organizers.

The organizers of the Conference have made block bookings at:

- <u>Tallink Spa and Conference Hotel</u> (105 EUR single occupancy, incl. breakfast)
- Tallink Express Hotel (70 EUR single occupancy, incl. breakfast)
- Nordic Hotel Forum (124 EUR single occupancy, incl. breakfast)

All hotels are located within walking distance of the Conference venue, with Nordic Hotel Forum being slightly further away (please see the maps in Annex 1).

(Copenhagen, Berlin, Rome).


The main electricity voltage is 220 V and 50 Hz. The Central
