It is centred around such topics as: public health employment outcomes, licencing and credentialing, public health job taxonomy, public health workforce development and planning, public health education at graduate and post graduate levels including continuing professional development (CPD) training, public health codes of ethics and professional conduct, enumeration and professional self-government. More specifically, the field focuses also on capacity building, competency-based education and training, systematic development of competency frameworks, competency development, self-assessment methods and identification of skill gaps for the provision of essential public health operations. The field is system specific, dependent on the stakeholders and governance structures. #### **ASPHER Young Professionals Programme**

Organiser: ASPHER

Ongoing Description: The ASPHER Young Professionals Programme is made up of public health early career professionals affiliated with ASPHER Member Schools. The YPP is an opportunity to join a supportive community of other young public health professionals, and provides the potential to join research

collaborations with researchers from around the world. The goal of the YPP programme is to incorporate public health students and professionals early in their career with the ASPHER network. The programme does this by: Building a network within the YPs that is maintained through monthly meetings and provides a medium for advice, feedback, and future collaboration; and incorporating YPs into ASPHER research collaborations to provide opportunities to gain relevant experience. YPs are expected to engage in monthly YPP meetings and actively participate in ASPHER research projects for a minimum of one year.

Membership is determined through an annual application intake period. is invited to apply to the ASPHER Young Professionals Programme (YPP). The 2023 cohort was made up of 15 YPs. The application period for the 2024 intake was open from September-December 2023. The Programme is led by ASPHER Executive Board Member Ines Siepmann.

#### **ASSETS Mentoring Summer School**

Organiser: ASPHER Dates: 03-06 July 2023 Location: Brussels, Belgium **Description:** Held for 1 week each year, the Andrija Stampar Summer Educational & Tutoring School (ASSETS) offers an exclusive educational mentoring programme tailored to initiate fruitful learning experiences. ASSETS seeks to strengthen public health professionals in their field of expertise and professional identity through the concept of career mentoring from distinguished and recognized experts in the field of public health.

Instead of a classical school with multiple lectures, each participant brings a schematic idea, about a practical experience, project, thesis or career challenge within the public health and/or health system scope that can be presented in class in front of the experts and their peers. These presentations thus create the input of the subsequent real-world problem based mentoring session.

## CORE COMPETENCIES AND CURRICULUM

#### ASPHER Core Curriculum Programme

Dates: Summer 2022-2024

Description: In Summer 2022 ASPHER began its review of public health core curriculum as a vital capacity and curriculum building project. Development of core public health competencies has been a common theme within ASPHER's operations since 2006. In 2022, it was agreed that a new direction was required. The Core Curriculum Programme strives to address the new normal which has enveloped the public health landscape after the global pandemic of COVID-19 and other crises.

ASPHER's vision of sustainable capacity-building in public health is more important than ever in the context of current population health challenges and threats. It is timely, therefore, to re-evaluate the 5th Edition of the ASPHER Core Competences for the Public Health Professional published in 2018, and to move towards agreeing a Core Curriculum in Public Health for academic and vocational training programmes that supports the attainment of competency according to existing Competency Frameworks and Essential Public Health Operations (EPHOs).

The Core Curriculum Programme relies on continuous connection, knowledge sharing and collegiality across many academic and public health practice sites across the globe both within and outside of the European region. The Programme is led by ASPHER Executive Board Member Mary Codd and ASPHER Fellow Karl Conyard.

#### One Health Conference – One Health for All, All for One Health

Mainstreaming 'One Health' means that we can better prevent, predict, prepare for, detect, and respond to global health threats at both global and EU level. # From analysis to action: Climate change litigation. A guide for public health professionals

Organiser: UK Faculty of Public Health

Date: November 2023

Description: Climate change is a public health emergency. The public health professional mandate requires not only the development of robust science and evidence, but also robust meaningful action. This guide therefore reflects input from multiple sources to assist public health professionals in supporting legal action that urges governments and the private sector to act now to address the climate crisis. Specifically, the guide: 1) Explains the phenomenon of climate change litigation for public health practitioners and provides an overview of key developments; 2) Identifies how the skills required to deliver compelling written and oral scientific evidence of human harms in climate change litigation can be grounded in public health competencies; and 3) Offers insights and lessons learned from prior climate change litigation, based all or in part on evidence of human harms. Invited speakers included Kristie Hadley (Global Consortium on Climate and Health Education), Mitsuo Sase (Planetary Health Report Card - Japan), and our own Chiara Cadeddu (Universita Cattolica del Sacro Cuore - Italy). Although there were some technical difficulties, it was a great session to learn about the global developments of integrating climate-change education. Description: ASPHER established a working group focused on examining the impact of digital transformations on public health education and training. ## Tallinn Charter 15th Anniversary High-level Conference "Trust and transformation: resilient and sustainable health systems for the future"
